➤ **First-ever Regional Anti-corruption Training for Officers and Youth in Asia-Pacific** (22 – 24 July 2025)

The Hong Kong International Academy Against Corruption (HKIAAC), in collaboration with the United Nations Office on Drugs and Crime (UNODC), the Office of the National Anti-Corruption Commission (ONACC) of Thailand, and the International Association of Anti-Corruption Authorities (IAACA), has launched a groundbreaking regional capacity-building programme focused on youth engagement in anti-corruption efforts. This initiative aims to enhance integrity training for young people across seven ASEAN member states and promote anti-corruption collaboration in the Asia-Pacific region.



A three-day training session was conducted at ONACC's headquarters, attended by over 200 representatives of various anti-corruption and law enforcement agencies from Brunei Darussalam, Cambodia, Indonesia, Myanmar, the Philippines and Singapore, along with young leaders from Brunei Darussalam and Thailand. The programme featured discussions on leveraging social media for promoting youth integrity and the creation of integrity promotion materials tailored for young audiences.

The ICAC continues to integrate youth capabilities into its international anti-corruption training programmes, inviting various agencies to participate.



Delegation of **Kenya** visits ICAC to foster international cooperation

(12 – 14 August 2025)

During the three-day visit, ICAC Commissioner Woo Ying-ming held a bilateral meeting with the six-member delegation led by Colonel (Rtd) Alfred Mshimba, Commissioner of the Ethics and Anti-Corruption Commission (EACC) of Kenya. The ICAC and the EACC had agreed to broaden the scope of cooperation between the HKIAAC and the National Integrity Academy of Kenya by stepping up collaboration in professional training and research on integrity measures. The two parties also explored cooperation in organising a regional anti-corruption training programme with a view to foster integrity building in Kenya and the African region.

Furthermore, the delegates and ICAC officers exchanged views on various practical issues in the fight against corruption. They also toured various ICAC facilities, as well as the ICAC Exhibition Hall and ICAC Regional Office, to understand the anti-graft enforcement work in Hong Kong and to experience the Commission's latest public education strategies with the application of new technology and innovative publicity ideas.



ICAC Officers invited to Sri Lanka to strengthen local anti-corruption capability



(19 – 21 August 2025)



In March, a high-level delegation from the Commission to Investigate Allegations of Bribery or Corruption (CIABOC) of Sri Lanka visited the ICAC for a five-day exchange on integrity building. The delegation was impressed by the success of Hong Kong's anti-corruption strategies, and extended an invitation to ICAC for professional sharing in Sri Lanka in the future. In response, representatives from the HKIAAC travelled to Colombo in August to conduct a three-day "Capacity Building Programme" for over a hundred CIABOC officers. The programme showcased Hong Kong's anti-corruption framework and latest strategies, and shared practical investigative experience.



The programme received joint support from the Asian Development Bank and the United Nations Development Programme, both of which have long been committed to promoting development in Sri Lanka. The closing ceremony was also honoured by the presence of Mr. Qi Zhenhong, Ambassador of the People's Republic of China to Sri Lanka, whose support added further significance to the event.

The ICAC will continue to provide professional training for anti-graft fighters worldwide in a bid to building a corruption-free world.

Experience Sharing on Integrity Management and Anti-Corruption in Cambodia with HKPF

(25 – 28 August 2025)

Recently, the ICAC and the Hong Kong Police Force (HKPF) joined hands again in sharing Hong Kong's integrity culture. Upon invitation by the Cambodian National Police and the Anti-Corruption Unit of Cambodia, representatives from the ICAC and the Service Quality Wing of the HKPF jointly hosted experience sharing sessions in Phnom Penh for local anti-graft officers and law enforcers, covering topics such as Hong Kong's anti-corruption legal framework and integrity management.



The delegation also met Mr. JIANG Nan, the Minister of the Embassy of the People's Republic of China in the Kingdom of Cambodia. At the meeting, Mr. JIANG expressed our country's fervent support for such joint efforts to promote international cooperation and exchange of experiences.

The ICAC and the HKPF will continue to foster international anti-corruption collaboration.
